Special conditions to be complied within three months:-

- a. The Extension of Provisional Affiliation up to Senior Secondary level w.e.f. 01/04/2015 to 31/03/2020 has been granted provisionally subject to the conditions that the school will pay the pay scale and allowances which should at least be at par with corresponding categories of teachers employed in government institutions of the State Govt. or as per scale prescribed in 6th Central Pay Commission of Govt. of India in respect of its teachers and will make the payment through ECS mode with proper deduction of EPF and other facilities as per norms of the Board. - b. d. As per letter dated 04/062012 of Up-gradation to +2, 1st Batch of student of Class XII should have appeared at +2 Board Examination for the year 2014 but as per online application, students of class XII had appeared for Board Examination in 2012 & 2013 as such the school is required to submit clarification for the same.

e. The number of students enrolled is very high in Class-I-XII. Therefore enrolment should be

maintained with optimum Number of 40 students in each section.
